a. Resolution A-2024 – Readopt 2024 Budget.

**WHEREAS**, the Annual Budget and Capital Budget for the Town of Newton Parking Authority for the fiscal year beginning, January 1, 2024 and ending, December 31, 2024 has been presented for re adoption before the Governing Body of the Parking Authority at its open public meeting of January 11, 2024; and

**WHEREAS**, the Annual Budget and Capital Budget as presented for re adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

**WHEREAS**, the Annual Budget as presented for re adoption reflects Total Revenues of \$129,000.00, Total Appropriations, including any Accumulated Deficit if any, of \$129,000.00 and Total Unrestricted Net Position utilized of \$0.00; and

**WHEREAS**, the Capital Budget as introduced reflects Total Capital Appropriations of \$12,000.00 and Total Unrestricted Net Position planned to be utilized as funding thereof, of \$12,000.00; and

**NOW, THEREFORE BE IT RESOLVED**, by the Governing Body of the Town of Newton Parking Authority, at an open public meeting held on January 11, 2024 that the Annual Budget and Capital Budget/Program of the Town of Newton Parking Authority for the fiscal year beginning, January 1, 2024 and ending, December 31, 2024 is hereby re adopted and shall constitute appropriations for the purposes stated; and

**BE IT FURTHER RESOLVED**, that the Annual Budget and Capital Budget/Program as presented for re adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services.
